### **ENFORCEMENT NOTICE - CHANGE OF USE**

1. This is a formal notice which is issued by the Council, because it appears to it that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of this notice contains important additional information.

#### 2. The land to which this notice relates

The land known as 8, Horninglow Croft, Burton upon Trent, Staffordshire, DE13 0SJ shown edged in red on the attached plan ("the Land").

## 3. The matters which appear to constitute the breach of planning control

Without planning permission, the material change of use of the Land from residential to a mixed use comprising of residential and a business providing pet services.

### 4. Reasons for issuing this notice

The Council considers it expedient to issue this notice for the following reasons:

- (1) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- (2) It is considered expedient to issue this notice in the interests of the amenity of the area.
- (3) NPPF states that effective enforcement is important as a means of maintaining confidence in the planning system
- (4) The change of use of the land is contrary to East Staffordshire Local Plan Policies SP1, SP24, DP1 and DP7, and the National Planning Policy Framework.
- (5) The Council does not consider that planning permission should be given, because planning conditions could not overcome the above objections.

### 5. What you are required to do

a) Permanently cease the use of the Land for providing the pet services business.

#### 6. Time for compliance

14 days beginning with the day on which this notice takes effect.

### 7. When this notice takes effect

This notice takes effect on Monday 29nd March 2021 unless an appeal is made against it beforehand.


