B1 What is the Decision?	To approve the contract extension for the on-line platform 'xCenta Essentials' from pib Risk Management to deal with incident reporting and investigation, risk assessment and e-learning training courses.
B2 What are the reasons for the Decision?	The market was extensively tested last year to find a replacement product for the existing platform from Safety Media - because that contract was due to expire. The replacement product was initially procured for 12 months so we could be assured that it would meet our needs. It has performed as expected and thus gives confidence in taking up the contract extension to 5 years.
B2 Alternative options considered and rejected?	Returning to the marketplace to seek proposals from other suppliers. This was rejected because there is a very limited supplier base which was explored only 12 months ago and the PIB product offered the best value and best fit to meet our needs.

East Staffordshire Borough Council is committed to providing and maintaining a healthy and safe place of work for all its employees, as well as taking all reasonable steps to ensure that the public and the environment (which may be affected by the work of the Council) are exposed to the lowest practicable level of risk.
