B1 What is the Decision?	To adopt the proposed provisions for a Public Space Protection Order for Princess Street Burton upon Trent.

B2 What are the reasons for the Decision?	The Councils current Public Space Protection Orders were reviewed and commenced in January 2022.
	Staffordshire Police approached the authority in 2023 to advise that behaviour and issues within the area of Princess Street, Burton upon Trent warranted consideration of a Public Space Protection Order to address anti-social behaviour.
	A comprehensive consultation exercise was undertaken regarding the proposed Orders which are as follows:
	East Staffordshire Borough Council is wishing to introduce a new Public Space Protection Order to control Anti-Social Behaviour. The Order is for Princess Street, Burton upon Trent and it is proposed to include the following restriction:
	The Council therefore: Prohibits, pursuant to section 59 of the Act, the Activity within the Restricted Area, unless the Activity is during or part of an associated Council endorsed special event;
	 It is an offence under this order for any individual(s) to cause harassment, alarm or distress to any individual(s) by committing anti- social behaviour. Examples may include: use of offensive or abusive language, acting in an aggressive manner.
	 Any individual is to disperse from the designated order area and not return within 12 hrs, unless for a lawful reason, if requested to do so by an authorised officer if the officer is of the opinion that the individual is causing harassment, alarm or distress. No person shall refuse to leave the location specified when given a direction to do so by an authorised officer, if they have a reasonable grounds to suspect that the behaviour of the person in the location has contributed or is likely to contribute to members of the public in the location being harassed, alarmed or distressed.
	 Unity Park - Any individual to leave the park when a by designated person tasked with locking Unity Parl allocated time by the Local Authority.
	 Persons within the area, on the request of a Police Constable, Police Community Support Officer or an authorised Officer are to comply with the request to dispose of or surrender any containers of alcohol in

possession or disperse from the order area and not return within 12hrs, unless for a lawful reason. Pers within the area, on the request of a Police Constable Police Community Support Officer or an authorised Officer are to comply with the request to dispose of surrender any containers of alcohol in their possess disperse from the order area and not return within the duration prescribed, unless for a lawful reason.
 No person shall refuse to stop drinking alcohol or hand over containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance and disorder. In accordance with s63 of the Act, a person found to be in breach of this order by consuming alcohol or by refusing to surrender alcohol to an authorised person is liable on a summary conviction to a maximum penalty of a level 2 fine. In accordance with s67 of the Act a person found to be in breach of this Order other than by consuming alcohol or by refusing to surrender alcohol to an authorised person is liable on a summary conviction to a maximum penalty of a level 2 fine. In accordance with s67 of the Act a person found to be in breach of this Order other than by consuming alcohol or by refusing to surrender alcohol to an authorised person is liable on summary conviction to a maximum penalty of a level 3 fine. An offence for any person, when requested by an authorised person, not to surrender any nitrous oxic
canister. Under Section 59 of the Act, the council can make a Public Space Protection Order if it is satisfied on
reasonable grounds that two conditions are met. The two conditions are as follows:
 (a) activities carried on in a public place within the authorities area have had a detrimental effect on the quality of life of those in the locality, or (b) it is likely that activities will be carried on in a public place within that area and that they will have such an effect.
The second condition is that the effect, or likely effect, of the activities:
 (a) is, or is likely to be, of a persistent or continuing nature , (b) is, or likely to be, such as to make the activities unreasonable, and

(c) Justifies the restrictions imposed by the notice.
The prohibitions and requirements to be imposed by the Public Space Protection Order are reasonable to include in the Order –
 (a) to prevent the detrimental effect referred to in subsection (2) from continuing , occurring or recurrence, or (b) to reduce that detrimental effect or to reduce the risk of its continuance, occurrence or recurrence.
Following the consultation exercise (consultees included, Staffordshire Police, ,Police, Fire and Crime Commissioner, Staffordshire Fire and Rescue Service, Trading Standards, Trent and Dove Housing, Staffordshire County Council, The Parish Council, ESBC Council Members, all shops and businesses within the locality, all residents within the locality) which concluded on 26 th June 2023 the authority received one response from a local Councillor and responded accordingly:
Response to Consultation: Any PSPOs for Unity Park are to be welcomed. However, I understood that the proposed order was to prohibit drug taking as there is a recognised problem? The order needs to also specifically prohibit anti-social behaviour as it is a major problem on the park. Drinking is only a relatively minor problem on the bench outside the entrance to the park and is not a major cause of disruption.
Councils Response to Consultation Feedback: There is a condition that attempts to address the nitrous oxide problem, with all other illegal drugs there are criminal sanctions for possession. There is also a condition to be ordered to leave an area if deemed to be causing ASB/Harassment, Alarm and Distress which drugs can be considered to do therefore should cover using/dealing drugs.
Anyone causing harassment, alarm or distress (ASB) will be in breach of the order which covers the second point.
The drinking condition is included as a positive step to address ASB.
