13/23 <u>CLIMATE CHANGE AND NATURE ACTION PLAN REVIEW OF PROGRESS 2022/23</u>

The report of the Head of Legal and Regulatory Services on the progress on the Climate Change and Nature Action Plan at the end of the 2022/23 financial year was considered. Appendix 1 The Climate Change and Nature Action Plan – Progress end 22-23 and Appendix 2 The Climate Change and Nature Action Plan – Completed Actions had been circulated with the report.

Cabinet noted that the Climate Change and Nature Action Plan contained 64 current actions and progress could be summarised as follows:

GREEN - 40 actions
AMBER - 0 actions
RED - 4 actions
GREY - 10 actions
Newly added - 10 actions

The Action Plan had also been restructured to reflect the four aims of the Climate Change and Nature Strategy published in October 2022. Additional sections had been added for cross-cutting actions that contribute to several aims. The six main sections of the revised Action Plan were as follows:

- 1. Aim 1 Protect climate from man-made climate change
- 2. Aim 2 Adapt to the consequences of climate change
- 3. Aim 3 Protect and enhance nature
- 4. Aim 4 Use resources wisely, and minimise waste and pollution
- 5. Cross-cutting actions
- 6. Communication and Engagement
