18/23 PERFORMANCE REPORT 2023/24 QUARTER 1: CORPORATE PLAN

The Report of the Head of Corporate and Environment Services, on the performance update on progress at the end of the first quarter of the 2023/24 financial year towards delivering East Staffordshire Borough Council's Corporate Plan, Leisure Services Contract Performance and Towns Fund Programme was considered. Appendix 1: Spreadsheet of Quarter 1 updates for Corporate Plan targets had been circulated with the report.

Councillors noted the report which stated that: out of 132 corporate targets, 82 were green, 6 were amber with 44 not yet due to be reported; of the 88 live targets, 93.18% were green status, 6.82% were amber status and 0% red status; at the end of Quarter 1 of the Leisure Contract Performance, 75 performance indicators were green, 3 were amber and 0 red; project progress on the Towns Fund Programme including key risks, current financial profiles, and claims for two projects: Cycle Network Enhancements (£780,049.76) and the College Project (£1,907,860).
