# 20/24 MONITORING OFFICER'S ANNUAL REPORT

Members considered the report of the Monitoring Officer on the annual review of the arrangements for the discharge of the Monitoring Officer's duties and proposals for amendments.

The Monitoring Officer informed Members that they had given advice to a number of Councillors about their obligations under the Code of Conduct; and had given advice and support to a number of Parish Clerks.

The Monitoring Officer informed Members that they had received 4 Standards complaints since the last Annual Report in 2023, composing as follows:

- 3 complaints were from Parish Councillors, and one complaint from a Borough Councillor.
- 2 of the 4 complaints are still live.

The Monitoring Officer confirmed to members there were still one outstanding complaint which is currently being considered by an external investigator.

The Monitoring Officer reported that the Localism Act 2011 requires the Council (and Parish/Town Councils for which it is responsible) to adopt a Code of Conduct for Councillors. All relevant Council's had adopted the Codes of Conduct.

The Monitoring Officer also reported that all Members of the Borough Council had completed their declaration of interest forms, they are required to update their declarations at least annually even if no changes are required. They reported they had received updated declarations since throughout the year, which suggests there was a high level of awareness among Councillors of the need to notify any changes as they occur.

In terms of Parish/ Town Councillors, the Monitoring Officer informed members that declarations from members of Outwoods, Stapenhill and Yoxall Parish Councils are still outstanding. The Monitoring Officer has formally written to these Councils requesting the declarations.
