"It is my duty to inform the council that over a short period of time prior to the election I posted on my private Facebook account several pictures, posters and a video encouraging people to vote conservative. Also on my private Facebook account are many pictures posts, and videos of my activities as Mayor of the Borough of East Staffordshire. One particular banner I placed saying "vote conservative" was placed on a picture of me wearing my chain while meeting H M The Queen and her representative Mr Ian Dudson the Lord Lieutenant. I now accept and acknowledge that these actions undermined the political neutrality of the office of Mayor. I further regret that in politicising a photograph of H M the Queen I could have caused her considerable embarrassment and undermine her political neutrality. I can also see that this was made more serious as it happened while the council was subject to purdah provision. I am honoured and privileged to hold the office of Mayor and recognise that I have a duty to uphold the neutrality and dignity of the office and as has been the case with my distinguished predecessors. I accept that in posting these pictures I was guilty of a significant lack of judgement. I wish to unreservedly apologise to H M the Queen and her representative for any embarrassment I may have caused and to the council for running the risk of bringing it into disrepute. I also wish to give an assurance that nothing like this will happen again."
