16/23 SCRUTINY REVIEW PROGRAMME UPDATE

Representatives from the Co-Operative Society, Richard Bickle and Jane Avery attended the meeting and provided an overview of the Co-Operative model as well as a question and answer session.

Councillors noted that with regard to secondary co-operatives, there would be a contributory payment/ financial contribution, whilst technically not all stakeholders needed to be officially involved, it would be unusual, with the more common method in bigger Co-operatives by having a Committee elected by the Co-operative members.

Councillors noted a Cooperative model could be applicable in 2 different environments concerning East Staffordshire Borough Council; the Market Hall and the Leisure Centre's.

Councillors noted there were currently 5 permanent traders in the Market Hall, with a minimum of two for a Co-operative approach, however, it would be dependent on the overhead costs as to what would make a successful Co-op.

The representatives of the Co-Operative Society would be able to advice as to the viability of proceeding with a Co-operative arrangement, and that any costs would be outlined in the Business Plan which would be prepared in the setting up.

Councillors noted that there needed to be a good use of the building, which would have natural support network from the public.

The following suggestions would be included in the Scoping Paper for the Scrutiny Review:

- Consult previous work carried out by the Committee
- A breakdown of Market Hall budgets and all associated costs be provided
- Information regarding the rental income of traders
- Ascertain the benefits co-operative models have to the community

It was highlighted by Councillors that for any consultation, a definition of the different cooperative models would be required. NOTED.

19/23 CORPORATE PLAN PERFORMANCE REPORT 2023/24 QUARTER 1

The Report of the Head of Corporate and Environment Services, on the performance update on progress at the end of the first quarter of the 2023/24 financial year towards delivering East Staffordshire Borough Council's Corporate Plan, Leisure Services Contract Performance and Towns Fund Programme was considered. Appendix 1: Spreadsheet of Quarter 1 updates for Corporate Plan targets had been circulated with the report.

Councillors noted the report which stated that: out of 132 corporate targets, 82 were green, 6 were amber with 44 not yet due to be reported; of the 88 live targets, 93.18% were green status, 6.82% were amber status and 0% red status; at the end of Quarter 1 of the Leisure Contract Performance, 75 performance indicators were green, 3 were amber and 0 red; project progress on the Towns Fund Programme including key risks, current financial profiles, and claims for two projects: Cycle Network Enhancements (\pounds 780,049.76) and the College Project (\pounds 1,907,860).

The Programmes and Transformation Team Leader would seek an update on whether the 6 Amber targets have been rectified.
