We did not intend to include those who did not sign the petition with a signature, but reading (3.1.3) we have decided to include their support.

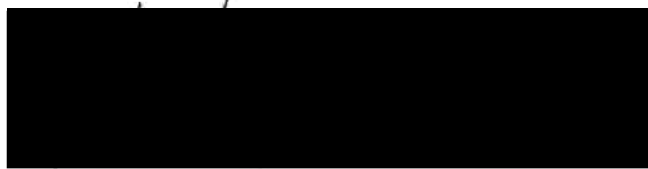
Also the badge numbers of each petitioner can guide to their post-code & phone number.


