The Report of the Head of Corporate and Environment Services, on the performance update on progress at the end of the second quarter of the 2023/24 financial year towards delivering East Staffordshire Borough Council's Corporate Plan, Leisure Services Contract Performance and Towns Fund Programme was considered. Appendix 2: Spreadsheet of Quarter 2 updates for Corporate Plan targets had been circulated with the report.

Councillors noted that out of 132 corporate targets, 114 were green, 2 were amber, 5 were red; 9 not yet due to be reported and 2 proposed for deletion; of the 121 live targets, 94.21% were green status, 1.65% were amber status and 4.13% red status; at the end of Quarter 2 of the Leisure Contract Performance, 78 performance indicators were green, 0 were amber and 0 red; project progress on the Towns Fund Programme including key risks, current financial profiles, and claims for Specialist College Offer Project: £3,494,864.26 (99.79% of grant award), with the following amounts being claimed but not yet paid: Cycle Network Project: £780,049.76 (41.1% of grant award). The total spend for the Council's own High Street project as of the end of Quarter Two was £6.1m from a total project budget of £20,259,335, representing 30% of the project budget.
