- Henry Warford Trust."

At recommendation 7.3 include the following wording after "substitute" and before "This would require" "with the exception of East Staffordshire Sports Council; Consolidated Charity of Burton; Uttoxeter Leisure and Development Company Ltd, thus allowing flexibility for both the Council and the outside body, where deemed necessary"; Recommendation 7.4 to remain".
